## INVESTMENT UNIVERSE AND PHILOSOPHY

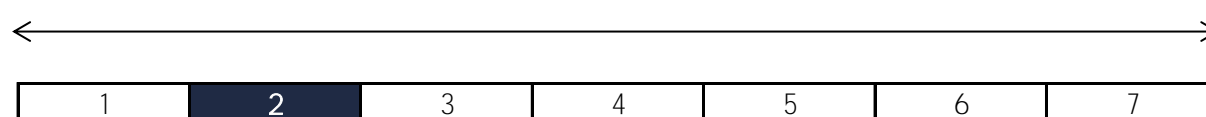

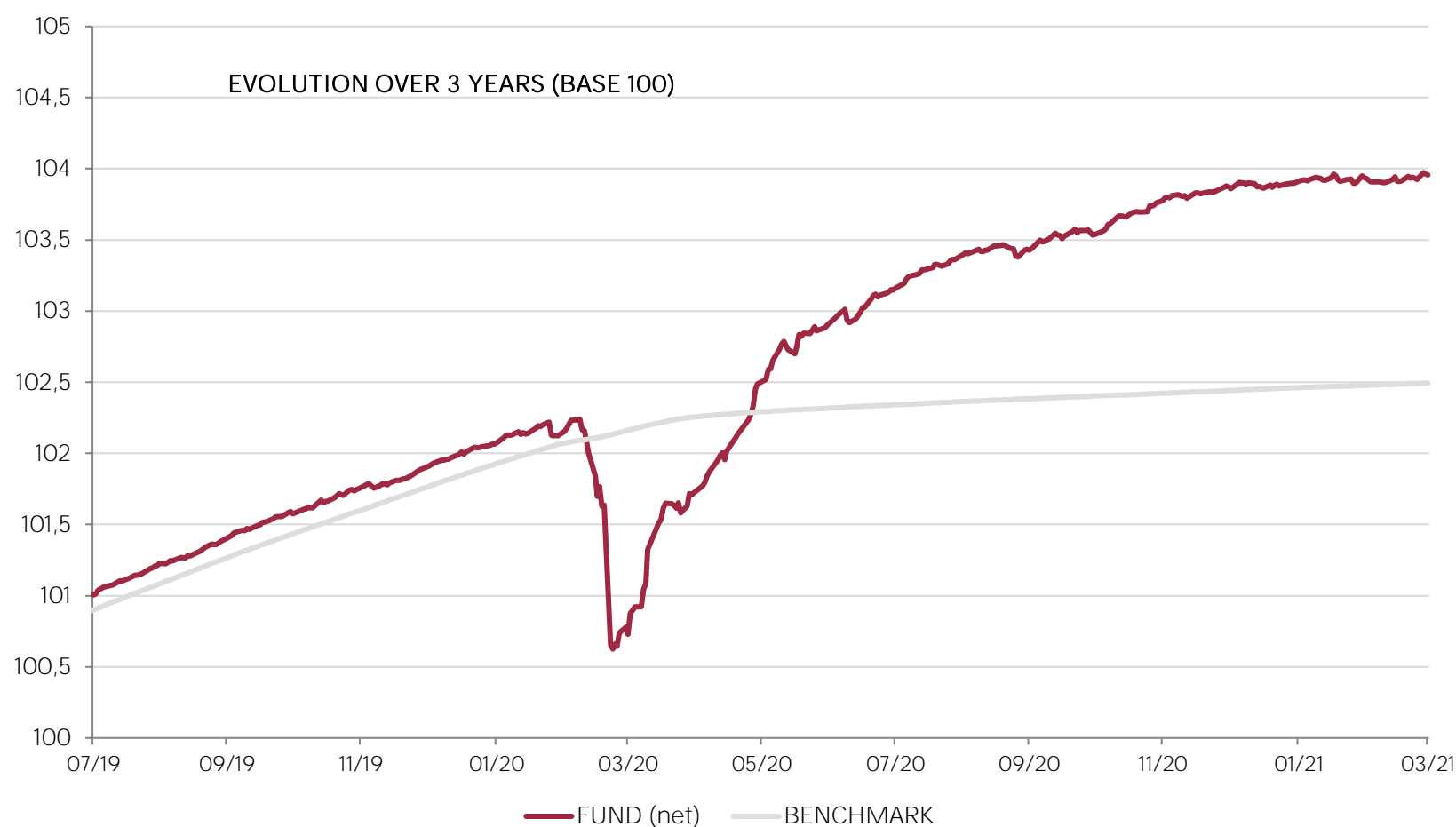

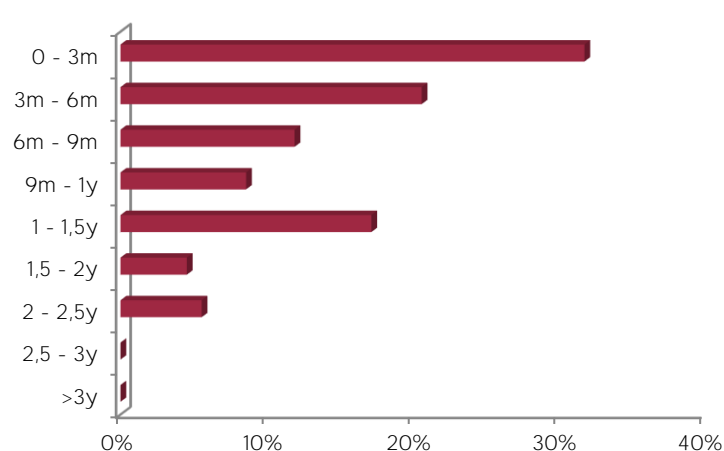
## SECTOR ALLOCATION



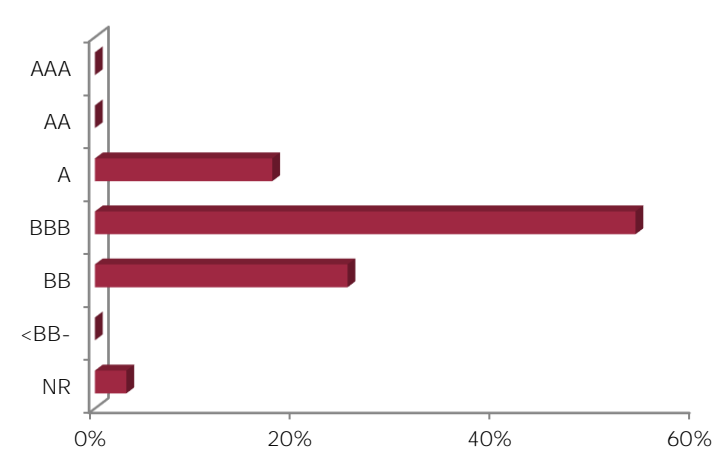
## COUNTRY ALLOCATION
