## INVESTMENT UNIVERSE AND PHILOSOPHY

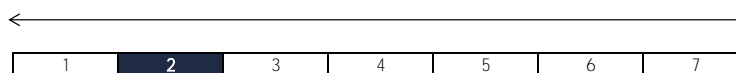

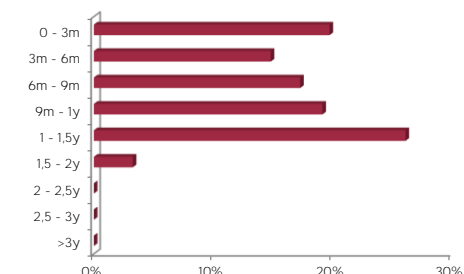
## SECTOR ALLOCATION



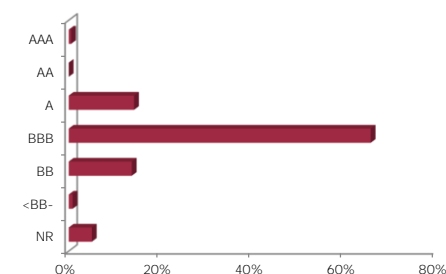
## COUNTRY ALLOCATION

## MANAGEMENT COMMENT

The US 2-year rate evolved in a range above +2.50%. This is the first target rate for US monetary policy to curb inflation. This tightening of monetary policy is a source of economic revision. In this sense, credit premiums have been revalued upwards. The phenomenon is also linked to the current elements of high commodities prices, geopolitical tensions in Europe, reduced activity in China. But also the revision of results in some sectors affected by overcosts, delivery problems or consumer confidence and the reallocation of their spending. It should be added that with higher interest rates, market players will automatically increase the margin on the credit component of bonds. The fund strategy is to maintain a low duration despite this first rates level reached by the markets and to avoid investment in cyclical sectors in the face of uncertainties. The average life of the fund remains low at around 11 months.
