INVESTMENT UNIVERSE AND PHILOSOPHY

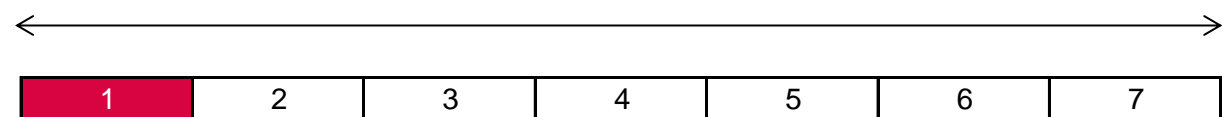

The management is discretionary and conviction based with weak interest rate and credit sensitivities and a strong diversification across issuers and sectors.

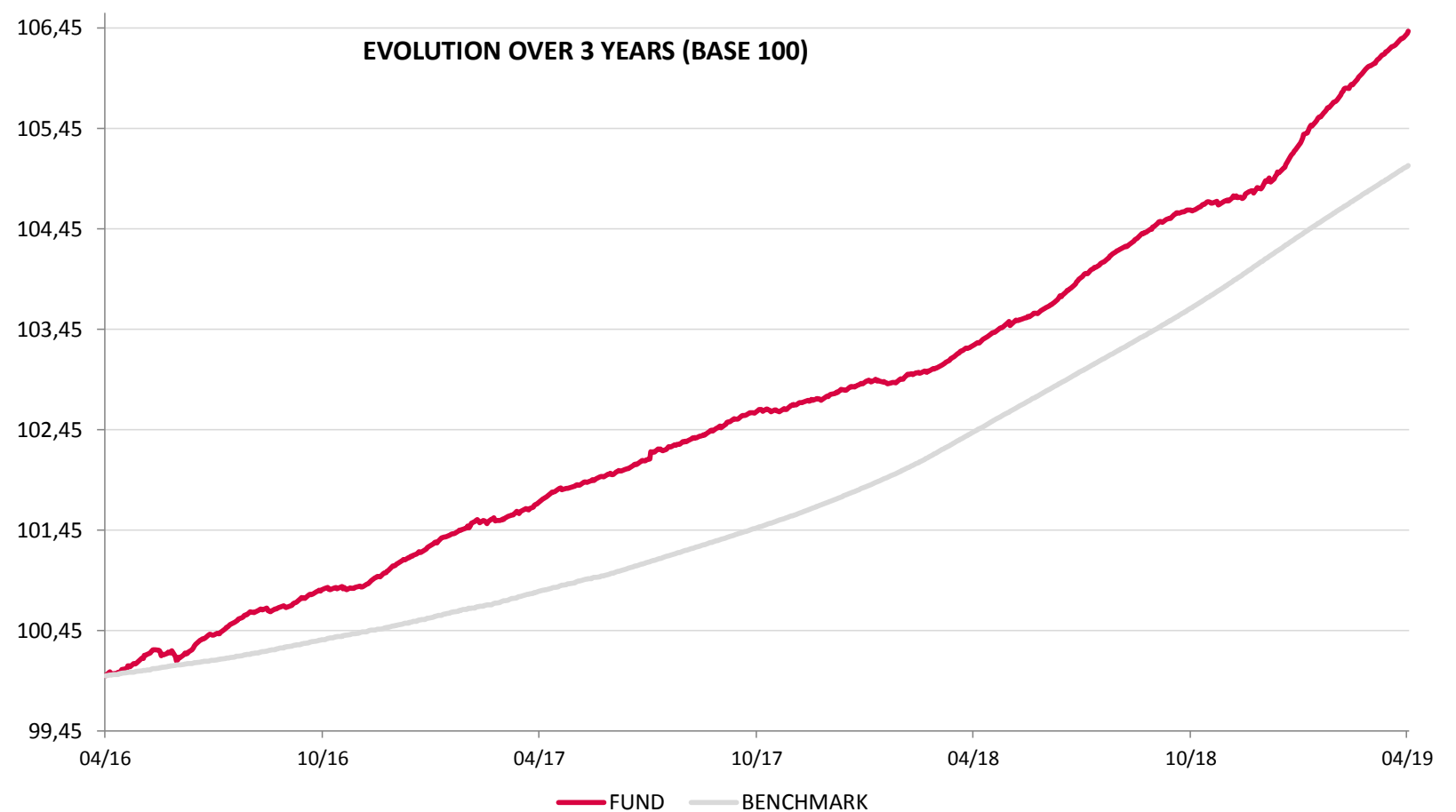

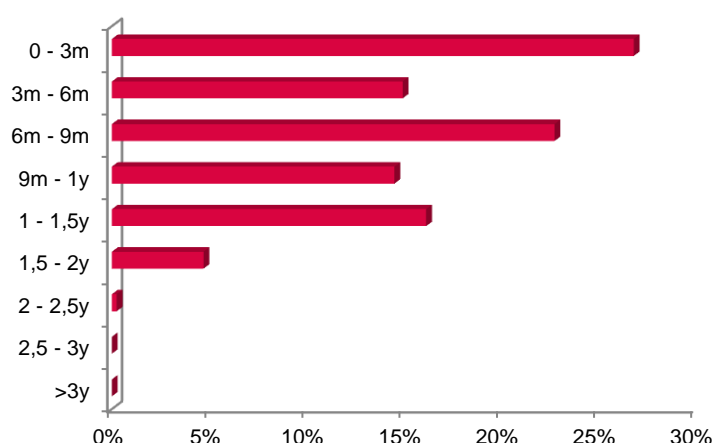
SECTOR ALLOCATION



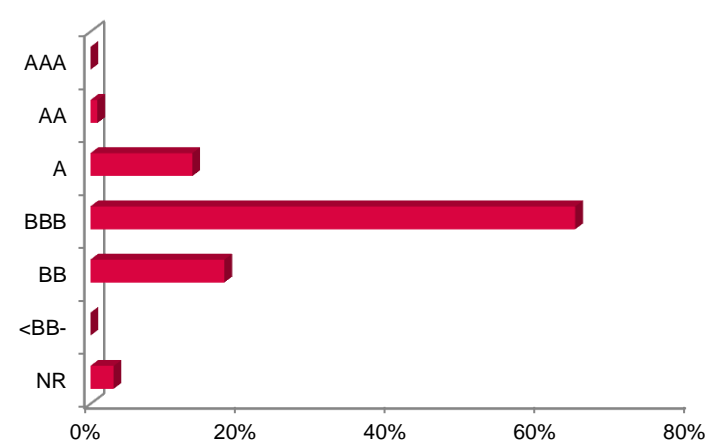
COUNTRY ALLOCATION
